1 **AN ACT** *to amend* 29.335, and *to create* 29.336 of the statutes; **relating to:**
2 prohibiting the feeding and baiting of deer.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 29.335 of the statutes is amended to read:

4 **29.335 Feeding wild animals for nonhunting purposes.** The Subject to
5 s. 29.336, the department shall promulgate rules to regulate the recreational and
6 supplemental feeding of wild animals for purposes other than hunting. The rules
7 ~~promulgated under this section do not apply after June 30, 2004.~~

8 **SECTION 2.** 29.336 of the statutes is created to read:

9 **“ 29.336 Feeding and baiting of deer.** The department may prohibit the
10 baiting or feeding of deer anywhere in the state for the purpose of controlling and
11 preventing the spread of chronic wasting disease. ”
