

Robert,

Please accept this correspondence as my request for a Senate Amendment to Assembly Substitute Amendment 1 to Assembly Bill 519, relating to feeding deer for viewing or hunting. Please contact Dan Johnson in my office if you have any questions.

The intent of this amendment is to allow for feeding of deer for hunting and viewing purposes in some portions of certain counties. That would be accomplished in the following manner:

1. Page 1, line 12 of ASA 1 to AB 519: delete "counties"
2. Page 2, lines 3-5: delete lines 3-5
3. Page 2, line 6: substitute "municipality" for "county". Thus, line 6-9 would read as follows:
 - A municipality in which the municipality or portion of the municipality is within a 10-mile radius of the known location of a captive or free-roaming domestic or wild animal that has been tested and confirmed to be positive for chronic wasting disease or bovine tuberculosis after December 31, 1997.
4. Page 2, line 10: after "in counties", insert "or municipalities"
5. Page 2, line 16: after "in counties, insert "or municipalities"

If "municipality" has to be defined, then I would ask for the purposed of this section that municipality be defined as "a city, village or township". So the amendment would only ban baiting and feeding of deer in any municipality that comes into contact with the 10-mile radius. It would continue to ban baiting and feeding in any county or portion of a county affected by the CWD zones.

Thank you for drafting LRB a0998/1, which is a Senate Amendment to ASA 1 to AB 519, relating to deer baiting and feeding. Senator Kedzie would like to add one component to that amendment. He would like to prohibit the use of animal parts in any material used for baiting and feeding.

Specifically, bait and feed material used for attracting deer may not contain honey, bones, fish, meat, solid animal fat or parts of animal carcasses.
