1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 7: after that line insert:

3 "SECTION 1m. <sup>x</sup> 939.51 (3) (a) of the statutes is amended to read:

4 939.51 (3) (a) ~~For~~ Except as provided in s. 947.07 (3) (a), for a Class A  
5 misdemeanor, a fine not to exceed \$10,000 or imprisonment not to exceed 9 months,  
6 or both."

7 2. Page 3, line 3: after that line insert:

8 "(3) (a) In lieu of or in addition to imposing penalties provided under s. 939.51  
9 (3) (a) for a violation of sub. (2), the court may require that the defendant perform  
10 a reasonable amount of community service work at a military or veterans' facility or  
11 for a public agency or a nonprofit organization that advocates for or provides services  
12 or benefits to veterans.
