Analysis by the Legislative Reference Bureau

Current law permits a school board to lease school sites, buildings, and equipment not needed for school purposes for a term not exceeding 15 years if approved at a school board meeting. This bill eliminates the limit on the term of the lease.

For further information see the *local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 120.13 (25) of the statutes is amended to read:

120.13 (25) LEASE SCHOOL PROPERTY. In addition to any other authority, lease school sites, buildings, and equipment not needed for school purposes to any person for any lawful use at a reasonable rental for a term not exceeding 15 years if approved at an annual or special school district meeting.
