AN ACT *to repeal* 560.25 (3); and *to amend* 20.143 (1) (ie) and 560.25 (4) of the statutes; **relating to:** manufacturing extension center grants and making an appropriation.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

1           **SECTION 1d.** 20.143 (1) (ie) of the statutes, as affected by 2003 Wisconsin Act  
2 33, is amended to read:

3           20.143 **(1)** (ie) *Wisconsin development fund, repayments.* All moneys received  
4 in repayment of grants or loans under s. 560.085 (4) (b), 1985 stats., s. 560.147, s.  
5 560.16, 1995 stats., s. 560.165, 1993 stats., subch. V of ch. 560 except s. 560.65, 1989  
6 Wisconsin Act 336, section 3015 (1m), 1989 Wisconsin Act 336, section 3015 (2m),  
7 1989 Wisconsin Act 336, section 3015 (3gx), 1997 Wisconsin Act 27, section 9110 (7f),

8 1997 Wisconsin Act 310, section 2 (2d), and 1999 Wisconsin Act 9, section 9110 (4),  
1 to be used for grants and loans under subch. V of ch. 560 except s. 560.65, for loans  
2 under s. 560.147, for grants under ss. 560.16 and 560.175, for assistance under s.  
3 560.06 (2), for the loan under 1999 Wisconsin Act 9, section 9110 (4), for the grant  
4 under 2001 Wisconsin Act 16, section 9110 (7g), for the grants under 2003 Wisconsin  
5 Act 33, section 9109 (1d) and (2q), and for reimbursements under s. 560.167. No  
6 moneys may be encumbered under this paragraph for grants under s. 560.25 after  
7 June 30, 2003.

8 **SECTION 1m.** 560.25 (3) of the statutes is repealed.

9 **SECTION 2.** 560.25 (4) of the statutes is amended to read:

10 560.25 (4) LIMIT ON GRANTS. The Beginning with fiscal year 2004–05, the  
11 department may not award more than \$1,000,000 \$1,500,000 in grants under this  
12 section in ~~a~~ each fiscal year.

13 **SECTION 3. Appropriation changes.**

14 (1) MANUFACTURING EXTENSION CENTER GRANTS.

15 (a) In the schedule under section 20.005 (3) of the statutes for the appropriation  
16 to the department of commerce under section 20.143 (1) (fj) of the statutes, as affected  
17 by the acts of 2003, the dollar amount is increased by \$750,000 for fiscal year 2003–04  
18 and the dollar amount is increased by \$750,000 for fiscal year 2004–05 to increase  
19 funding for the purpose for which the appropriation is made.

20 (b) In the schedule under section 20.005 (3) of the statutes for the appropriation  
21 to the department of commerce under section 20.143 (1) (c) of the statutes, as affected  
22 by the acts of 2003, the dollar amount is decreased by \$1,500,000 for fiscal year  
23 2003–04 to decrease funding for the purpose for which the appropriation is made.
