12 under s. 560.147, for grants under ss. 560.16 and 560.175, for assistance under s.
13 560.06 (2), for the loan under 1999 Wisconsin Act 9, section 9110 (4), for the grant

11 ~~“(b) Notwithstanding section 20.001 (3) (c) of the statutes, no later than June~~

12 30, 2005, the department of commerce shall, pursuant to a plan approved by the
13 secretary of administration, lapse to the general fund any or all of the unencumbered
14 balance in any or all of the appropriations under section 20.143 of the statutes, except
15 that the total amount of the moneys lapsed under this paragraph may not exceed
16 \$1,500,000 and no lapse shall be made from any appropriation account or segregated
17 fund if the lapse would violate a condition imposed by the federal government on the
18 expenditure of moneys or if the lapse would violate state law or the federal or state
19 constitution.”.
