✓ SECTION ^{3M} 20.510 (1) (t) of the statutes is created to read:

20.510 (1) (t) *Election administration*. From the election administration fund, the amounts in the schedule to meet federal requirements for the conduct of federal elections under P.L. 107-252. All moneys transferred from the appropriation ^{account} under par. (d) shall be credited to this appropriation account.”
