


Good afternoon Debora, I apologize for the delay in sending this off to you. As we briefly discussed, with the final publication of the Federal Regulations concerning HIPAA unique identifiers last week Friday, the initial applicability included in AB 560 should be technically amended now that the feds have given firm compliance dates. The following is language Dick Sweet and I have worked out:

**Page 2, line 10: delete lines 10 to 13 and substitute:**

**"(2) Beginning on the first day on which small health plans are required to comply with a U.S. Department of Health and Human Services regulation under 42 USC 1320d-2 (b) that requires use of a unique identifier for health care purposes, no person may do any of the following:"**
