TO 2003 SENATE BILL 113

1 At the locations indicated, amend the bill as follows: ✓

2 1. Page 2, line 3: after that line insert:

3 (1m) ^{plais} ^{CS} Request by legislator. ← CS

4 in the legislature and referred to a standing committee of the house in which it is
5 introduced, the chairperson may request that the department prepare an energy
6 impact report. If the proposal is not referred to a standing committee, the speaker
7 of the assembly, if the proposal is introduced or offered in the assembly, or the
8 presiding officer of the senate, if the proposal is introduced or offered in the senate,
9 may request that the department prepare an energy impact report.

10 2. Page 2, line 5: after "legislature" insert "and the chairperson of a standing
11 committee requests that the department prepare an energy impact report".

12 3. Page 2, line 6: delete "it is introduced or offered" and substitute "the
13 chairperson makes the request".
