5 date of this paragraph [revisor inserts date], has ~~constructed~~ any facility for
6 providing cable service directly or indirectly to the public.”.
- 7 **2.** Page 2, line 9: on page 1, line 9, of the material inserted by senate
8 amendment 1, delete ““(b)” and substitute “(b)”.
- 9 **3.** Page 3, line 7: on page 1, line 8, of the material inserted by senate
10 amendment 2, delete “sub. (3)” and substitute “subs. (3) and (3m)”.
- 11 **4.** Page 3, line 23: after that line, on page 2 of the material inserted by senate
12 amendment 2, after line 16 insert:
