**SENATE AMENDMENT ,  
TO 2003 SENATE BILL 399 ✓**

Now

1 At the locations indicated, amend the bill as follows: ✓

2 ✓ 1. Page 3, line 1: delete the material beginning with "prepare" and ending with  
3 "registrar" on line 2 and substitute "prepare the certificate and provide it to the  
4 parent or parents requesting it".

5 ✓ 2. Page 3, line 8: delete "filing" and substitute "preparation".

6 ✓ 3. Page 3, line 10: delete the material beginning with that line and ending with  
7 page 4, line 12, and substitute:

8 "3) RULES. The department shall promulgate rules prescribing the form of,  
9 and information to be included on, a certificate of birth resulting in stillbirth, which  
10 shall be as similar as possible to the form of and information included on a certificate

1 of birth. The department shall provide assistance and instruction as necessary to  
2 hospitals in the preparation of certificates of birth resulting in stillbirth.”
