2 1. Page 3, line 11: after that line insert:

3 "2m. "Fair market value" means, with respect to a terminated wholesaler's
4 distribution rights to a discontinued brand of fermented malt beverages, the net
5 profit from sales of the discontinued brand within the 12 months immediately
6 preceding the date that the terminated wholesaler's agreement was terminated,
7 cancelled, or not renewed, as described in subd. 4."
