

**SENATE AMENDMENT 3,
TO 2003 SENATE BILL 407**

March 2, 2004 – Offered by Senators DECKER, KEDZIE, BROWN, M. MEYER, BRESKE,
PANZER, ZIEN, DARLING and HANSEN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 6: after “deer,” insert “eliminating back tags for hunting,”.

3 **2.** Page 2, line 1: before that line insert:

4 “**SECTION 1d.** 29.024 (6) (am) of the statutes is repealed.

5 **SECTION 1f.** 29.024 (6) (b) of the statutes is amended to read:

6 29.024 **(6)** (b) The clerk of each county appointed under par. (a) 2. ~~or (am) 2.~~ may
7 accept the appointment.

8 **SECTION 1h.** 29.024 (6) (d) of the statutes is amended to read:

9 29.024 **(6)** (d) The department may promulgate rules regulating the activities
10 of persons appointed under pars. (a) 2., 3. and 4. ~~and (am) 2. and 3.~~

11 **SECTION 1k.** 29.024 (7) of the statutes is amended to read:

12 29.024 **(7)** **DUPLICATES.** If any license, permit, certificate or card is lost, the
13 person to whom the license, permit, certificate or card was issued may apply to the

1 department for a duplicate by submitting an affidavit proving loss. The department
2 may accept information in a form other than an affidavit. The department shall
3 make an inquiry and investigation as it considers necessary. If the department is
4 satisfied that the loss has been proven, the department may issue a duplicate license,
5 permit, certificate or card to the applicant. ~~Back tags and other tags~~ Tags issued with
6 a license, permit, certificate or card are parts of the license, permit, certificate or card
7 and loss of any part is considered to be loss of the entire license, permit, certificate
8 or card. Upon applying for a duplicate license, permit, certificate or card, the
9 applicant shall surrender all parts of the original remaining in his or her possession
10 to the department. No duplicate stamp may be issued and if a stamp is lost, the
11 person to whom it was issued is required to apply and pay the regular fee in order
12 to receive a new stamp.”.

13 **3.** Page 2, line 1: substitute “**1m**” for “**1**”.

14 **4.** Page 2, line 17: after that line insert:

15 “**SECTION 2g.** 29.171 (3) of the statutes is amended to read:

16 29.171 (**3**) The department shall issue to each person who is issued a resident
17 archer hunting license a deer tag ~~and a back tag~~.

18 **SECTION 2m.** 29.173 (3) of the statutes is amended to read:

19 29.173 (**3**) ~~DEER TAG AND BACK TAG.~~ The department shall issue to each person
20 who is issued a resident deer hunting license a deer tag ~~and a back tag~~.”.

21 **5.** Page 3, line 2: after that line insert:

22 “**SECTION 3m.** 29.182 (4) (g) of the statutes is amended to read:

23 29.182 (**4**) (g) The organization known as the Rocky Mountain Elk Foundation
24 shall transfer the license awarded or under par. (f) only to a person who is qualified

1 to receive a resident elk hunting license and shall transfer to that person the carcass
2 tag ~~and back tag~~ that was issued by the department to the organization under ~~subs.~~
3 sub. (6) ~~and (7)~~.

4 **SECTION 3p.** 29.182 (7) of the statutes is repealed.

5 **SECTION 3r.** 29.184 (9) of the statutes is repealed.

6 **SECTION 3s.** 29.211 (3) of the statutes is amended to read:

7 29.211 **(3)** ~~DEER TAG AND BACK TAG.~~ The department shall issue to each person
8 who is issued a nonresident deer hunting license a deer tag ~~and a back tag~~.

9 **SECTION 3u.** 29.216 (3) of the statutes is amended to read:

10 29.216 **(3)** ~~DEER TAG AND BACK TAG.~~ The department shall issue to each person
11 who is issued a nonresident archer hunting license a deer tag ~~and a back tag~~.

12 **SECTION 3w.** 29.231 (4) of the statutes is amended to read:

13 29.231 **(4)** The department shall issue to each person who is issued a sports
14 license a deer tag ~~and back tag~~.

15 **SECTION 3y.** 29.235 (4) of the statutes is amended to read:

16 29.235 **(4)** ~~DEER TAG AND BACK TAG.~~ The department shall issue to each person
17 who is issued a conservation patron license a deer tag ~~and back tag~~.”.

18 **6.** Page 3, line 3: delete lines 3 to 7 and substitute:

19 “**SECTION 4m.** 29.301 (3) of the statutes is repealed.”.

20 **7.** Page 3, line 21: after that line insert:

21 “**SECTION 5d.** 29.561 of the statutes is repealed.

22 **SECTION 5g.** 29.563 (14) (bn) of the statutes is repealed.

23 **SECTION 5j.** 29.563 (14) (c) 5. of the statutes is repealed.”.
