#### **Assumptions Used in Arriving at Fiscal Estimate**

This bill specifies that it is not employment discrimination for an employer to refuse to employ or to terminate from employment any individual who has been convicted of a felony and who has not been pardoned for that felony.

The Equal Rights Division of the Department of Workforce Development enforces this portion of the statute and receives approximately fifty cases per year that allege discrimination based on a felony conviction. Although passage of this legislation may result in some reduction in case load because of the removal of protection for some potential complainants, the case load reduction would not be significant enough to result in an overall decrease in costs, since each Equal Rights Officer is expected to handle 132 cases per year.

Informational brochures on the law that are published by the Equal Rights Division will need to be reprinted at a one-time cost of \$1,000 GPR. This cost will be absorbed by the agency.

This bill is also unlikely to have any significant impact on local government costs since only the small number of local governments that have a related case would have had costs.

#### **Long-Range Fiscal Implications**

The bill has no long range fiscal implications for the Equal Rights Division.
