**Assumptions Used in Arriving at Fiscal Estimate**

The bill would invalidate present or potential local ordinances prohibiting reselling tickets. This would remove local revenues resulting from ordinance violations where such cases may be prosecuted.

There is one potential state effect, in that for events not soldout the resold tickets could supplant part of the market for original tickets, the state would lose sales tax revenue charged on original tickets but not on resold tickets. Since some jurisdictions have county sales taxes this could be another local effect on revenues.
