**Bill Summary**

This bill clarifies that individuals who are at least 14 years old can receive a sturgeon spearing license without having any other fishing license.

**Fiscal Effect**

This bill has no state or local fiscal impact. Fishing licenses are not required for 14 and 15 year olds and have not been necessary in order to purchase a sturgeon spearing license. No revenue was previously collected for these licenses and there would be no impact on Department revenue collections. There are no additional costs to implement this change.
