The remnants of the same Marine Battalion were told one year earlier that the whole 3rd Marine Division were being pulled out of Vietnam.

On October 9, 1969 their position was overrun by an NVA Sapper attack killing many of those expecting to go home.

One of those men who made it home and was discharge in 1970, rode a 350cc Honda back to Wisconsin in 2 and a half days.

Mr. Stevens has devoted over four decades of his time, effort and compassion to teaching the children of University School, and has trained several generations of scholars, including many of Wisconsin’s business and community leaders.
