



2003 ASSEMBLY RESOLUTION 29

November 12, 2003 - Introduced by COMMITTEE ON RULES.

1 **Relating to:** establishing special orders of business for Thursday, November 13,
2 2003.

3 *Resolved by the assembly, That:*

SECTION 1. Special order scheduled. The following proposals shall be special orders of business on Thursday, November 13, 2003, at the times shown:

- (1) At 8:01 a.m., 2003 Assembly Bill 632, relating to: construction of electric generating facilities and transmission lines, and granting rule-making authority.
- (2) At 8:02 a.m., 2003 Senate Bill 300, relating to: construction of electric generating facilities and transmission lines, and granting rule-making authority.
- (3) At 8:03 a.m., 2003 Senate Bill 128, relating to: the disclosure of public library records.
- (4) At 8:04 a.m., 2003 Senate Bill 170, relating to: the Veterans Mortgage Loan Program, veterans tuition and fee reimbursement, authority for the Department of Veterans Affairs to acquire a headquarters building, departmental delivery of services to veterans, veterans personal loans, eligibility for burial at a veterans cemetery, part-time study grants for veterans, housing loans for veterans, mortgage loan repayment fund, grants to county veteran service offices, national guard tuition grants, granting rule-making authority, and making an appropriation.

- (6) At 8:06 a.m., 2003 Assembly Bill 626, relating to: an income tax and franchise tax credit for training apprentices.

- (8) At 8:08 a.m., 2003 Assembly Bill 206, relating to: pointing a firearm at certain persons and throwing or expelling bodily substances and providing penalties.

- (22) At 8:22 a.m., 2003 Assembly Bill 169, relating to: the disclosure of public library records.
