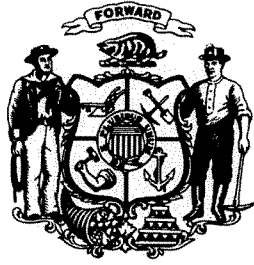


**Assembly Joint Resolution 52, Related to: Calling for concerted action to support, renew, and expand the agricultural economy in Wisconsin.**

<b>BILL SPONSORS</b>	<p>Introduced by <b>Senators Schultz, Welch, Brown, Decker, A. Lasee, Leibham, Roessler, S. Fitzgerald, Harsdorf, Lassa and Hansen.</b></p> <p>Cosponsored by <b>Representative Ott.</b></p>
<b>BILL HISTORY</b>	<p>Assembly Joint Resolution 52 was introduced on 10/27/03 and referred to the Assembly Committee on Agriculture.</p> <p>A public hearing and executive session were held on 10/30/03.</p> <p><b>The Assembly Committee recommended AJR 52 for passage on a vote, 14-0.</b></p> <p>AJR 52 was received from the Assembly on 11/13/03 and referred to the Agriculture, Financial Institutions and Insurance Committee.</p> <p>A public hearing and executive session were held on 12/02/03.</p> <p><b>The Senate Committee Concurred on AJR 52 on a vote, 5-0.</b></p>
