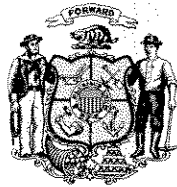

Please find attached paper ballots for the following:


- **Senate Bill 516** (Roessler/Huebsch) relating to a trial jobs plus demonstration project under the Wisconsin Works program.
