*Analysis by the Legislative Reference Bureau*

Current laws requires each state agency to submit every six<sup>✓</sup> years a report that contains a description of each programmatic activity of the state agency and information relating to expenditures and revenue sources for each programmatic activity. This bill requires that once a state agency has used a certain format for its report, the state agency must use that format for all future reports. ✓

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 16.423 (5) of the statutes is created to read: ✓
