### Analysis by the Legislative Reference Bureau

Under current law, the secretary of natural resources is nominated by the governor, and with the advice and consent of the senate appointed, to serve at the pleasure of the governor. Under this bill, the Natural Resources Board appoints the secretary of natural resources.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION 1.** 15.05 (1) (b) of the statutes is amended to read:

1/5.05 (1) (b) Except as provided in pars. (c) and par. (d), if a department is under

the direction and supervision of a board, the board shall appoint a secretary to serve

at the pleasure of the board outside the classified service. In such departments, the

powers and duties of the board shall be regulatory, advisory, and policy-making, and

not administrative. All of the administrative powers and duties of the department
