#### Subject

Exempting certain health care professionals from discipline and liability for refusing to participate in abortions, sterilizations, euthanasia, and certain other procedures on moral or religious groun

#### **Assumptions Used in Arriving at Fiscal Estimate**

AB-207 provides that health care professionals would be exempt from disciplinary action by the Medical, Pharmacy, and Nursing Examining Boards if they refuse for reasons of religious belief to participate in certain procedures.

The Department of Regulation and Licensing would expect an increase in the number of complaint investigations and resolutions. If the number of complaints requiring investigation is 10, the fiscal impact is detailed below:

#### TOTAL ANNUALIZED COSTS = \$14,388

DRL assumes 10 complaints would be received annually against health professionals for refusing care.

DRL assumes 7 complaints would be resolved after investigation using staff time with the value listed below:

All salary amounts include fringe benefits at 40.64%

35 hours Program Assistant \$ 595 42 hours Investigator \$1,092 7 hours Attorney \$ 371

DRL assumes 3 complaints would go to hearing or stipulation for resolution

15 hours Program Assistant \$ 255 18 hours Investigator \$ 468 99 hours Attorney \$5,247 120 hours Administrative Law Judge \$6,360

DRL also notes that the bill permits practitioners who are disciplined by their regulatory boards to sue the board and the agency. DRL assumes that defending the department and boards would incur some costs, but we cannot determine the number of lawsuits that might be filed, the costs of defense or what appropriations might pay these costs.
