# ASSEMBLY AMENDMENT, TO 2005 ASSEMBLY BILL 207

At the locations indicated, amend the bill as follows:

- **1.** Page 5, line 13: after "hydration" insert ", unless the individual is in a persistent vegetative state, the withholding or withdrawal is ordered by a court, and the employee or prospective employee refuses to transfer the individual to another qualified person who will comply with the court order". ✓
- **2.** Page 8, line 6: after "hydration" insert ", unless the individual is in a persistent vegetative state, the withholding or withdrawal is ordered by a court, and the health care facility refuses to transfer the individual to another qualified facility who will comply with the court order".  $\vee$
- 3. Page 11, line 20: after "hydration" insert ", unless the individual is in a persistent vegetative state, the withholding or withdrawal is ordered by a court, and

the person licensed as a registered nurse or as a practical nurse refuses to transfer the individual to another qualified person who will comply with the court order".  $\sqrt{\phantom{a}}$ 

- **4.** Page 14, line 9: after "hydration" insert ", unless the individual is in a persistent vegetative state, the withholding or withdrawal is ordered by a court, and the person licensed or certified under this subchapter refuses to transfer the individual to another qualified person who will comply with the court order".
- **5.** Page 16, line 16: after "hydration" insert ", unless the individual is in a persistent vegetative state, the withholding or withdrawal is ordered by a court, and the pharmacist refuses to transfer the individual to another qualified person who will comply with the court order".
