**ASSEMBLY AMENDMENT ,  
TO 2005 ASSEMBLY BILL 207**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 5, line 13: after "hydration" insert ", unless the individual is in a  
3 persistent vegetative state, the withholding or withdrawal is ordered by a court, and  
4 the employee or prospective employee refuses to transfer the individual to another  
5 qualified person who will comply with the court order". ✓

6 **2.** Page 8, line 6: after "hydration" insert ", unless the individual is in a  
7 persistent vegetative state, the withholding or withdrawal is ordered by a court, and  
8 the health care facility refuses to transfer the individual to another qualified facility  
9 who will comply with the court order". ✓

10 **3.** Page 11, line 20: after "hydration" insert ", unless the individual is in a  
11 persistent vegetative state, the withholding or withdrawal is ordered by a court, and

1 the person licensed as a registered nurse or as a practical nurse refuses to transfer  
2 the individual to another qualified person who will comply with the court order". ✓

3 **4.** Page 14, line 9: after "hydration" insert ", unless the individual is in a  
4 persistent vegetative state, the withholding or withdrawal is ordered by a court, and  
5 the person licensed or certified under this subchapter refuses to transfer the  
6 individual to another qualified person who will comply with the court order". ✓

7 **5.** Page 16, line 16: after "hydration" insert ", unless the individual is in a  
8 persistent vegetative state, the withholding or withdrawal is ordered by a court, and  
9 the pharmacist refuses to transfer the individual to another qualified person who  
10 will comply with the court order". ✓
