

TO 2005 ASSEMBLY BILL 207

At the locations indicated, amend the bill as follows: 1. Page 5, line 19: after that line insert: 2 "Section 4m. 111.337 (2) (c) of the statutes is created to read: 3 111.337 (2) (c) For an employer with five or fewer employees to engage in the 4 5 activity described in sub. (1r) (b). In this paragraph, "employees" do not include individuals who related to the employer within the second degree of kinship under 6 7 s. 990.001 (16).". 8 (END)

At the Page 17, line 14: delete "and (IW)" and substitute ", (IW), and (2)(c)".
