Hi Chris.

Rep. Sheridan would like to have some amendments drafted for Tuesday on AB 207.

1. Please redraft AA2 to AB 207 for the floor.
- 2. Please draft an amendment to grant an exception for small businesses (to be defined as 5 employees or less, not counting family members).
3. Please draft an amendment to guarantee the right of employers to transfer employees to positions that do not cause a moral conflict for the employee.
4. Please draft an amendment to amend Section 450.155(1)(a) of the Statutes to define pregnancy "as defined by the American College of Obstetricians and Gynecologists." I am currently waiting for a call back from ACOG's State Legislative Director, but the amendment needn't wait.

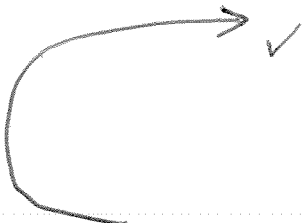
1 At the locations indicated, amend the bill as follows:

4 111.337 (2) (c) For an employer with five or fewer employees to engage in the
5 activity described in sub. (1r) (b). In this paragraph, "employees" do not include
6 individuals who ^{are} related to the employer within the second degree of kinship under
7 s. 990.001 (16)."
