ASSEMBLY AMENDMENT,
TO 2005 ASSEMBLY BILL 207

1 At the locations indicated, amend the bill as follows:

2 1. Page 17, line 12: after that line insert:

3 “(4) A person licensed as a pharmacist under this chapter who refuses, on moral
4 or religious grounds, to participate in dispensing a prescribed drug or device, may
5 not dispense any drug or device approved by the federal food and drug
6 administration for the treatment of erectile dysfunction.”
