TO 2005 ASSEMBLY BILL 207

1 At the locations indicated, amend the bill as follows:

2 1. Page 16, line 1: delete "A person" and substitute "Subject to sub. (4), a  
3 person".

*on moral or  
religious grounds*

4 2. Page 17, line 14: after that line insert:

*participate  
in dispensing*

5 "(4) If a person licensed as a pharmacist under this chapter refuses to dispense  
6 an oral contraceptive *drug* and a court finds that the person's refusal proximately caused  
7 the birth of a child, the court shall require the person to contribute to the support of  
8 the child."
