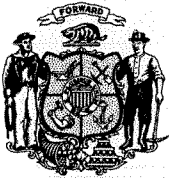

ASSEMBLY AMENDMENT,
TO 2005 ASSEMBLY BILL 207

Now

1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 4, line 4: delete the material beginning with "unless" and ending with
3 "business" on line 6 and substitute "~~unless the employer can demonstrate that the~~
4 ~~accommodation would pose an undue hardship on the employer's program,~~
5 ~~enterprise, or business~~".

6 ✓ 2. Page 5, line 21: after that line insert:

7 "SECTION 4m. 111.34 (1) (b) of the statutes is amended to read:

8 111.34 (1) (b) Refusing to reasonably accommodate an employee's or
9 prospective employee's disability ~~unless the employer can demonstrate that the~~
10 ~~accommodation would pose a hardship on the employer's program, enterprise or~~
11 ~~business.~~".
