1 At the locations indicated, amend the bill as follows:

2 1. Page 15, line 10: delete lines 10 and 11 and substitute:

3 "(a) "Airport development project" means a business that locates or expands in  
4 an area designated as an airport development zone in this state."

5 2. Page 15, line 19: after "each" insert "county,".

6 3. Page 16, line 1: after that line insert:

7 "6. That an airport is located in the area designated as an airport development  
8 zone, that the airport has at least 2 runways at the time of the designation, and that  
9 the airport's primary runway is at least 5,000 feet in length and its secondary runway  
10 is at least 3,000 feet in length."

11 4. Page 17, line 2: after "each" insert "county,".

12 5. Page 17, line 8: after the period insert "The total tax benefits applicable to  
13 all airport development zones may not exceed \$9,000,000. The department may,

1 after 48 months from the month of any designation under this section, evaluate the  
2 area designated as an airport development zone and reallocate the amount of  
3 available tax benefits.”.

6. Page 17, line 18: after “each” insert “county,”. ✓

7. Page 19, line 23: delete “2005” and substitute “2006”. ✓
