

Simple amendments to AB 327

\* By Monday PM

1. Require UCA to have at least 5 patron members (include conditions on patron members under current s. 185.043
  - one must be WI resident
  - all adults
2. Board authority: allow allocation of voting authority according to allocation units only if directors elected by patron members have at least 67 percent (not 51) of the voting authority, etc.
3. Allocation of profits, losses, distributions between members: delete provision permitting allocation to be reduced to 30% of total profits
  - to patron membership interests
