

Dave,

With regards to the suggested changes:

1. Changing the relating clause, as you suggested, makes no substantive change to the bill and is not an accurate statement of how the bill operates. The disabled veteran does not receive a refund of property taxes, but instead receives credit for the full amount before the taxes are actually due/paid. In other words, the veteran receives a bill for "0 dollars" not a refund of an amount he's already paid.

2. I can draft an amendment to change "unmarried surviving spouse" to "unremarried surviving spouse" if that's your preference. Let me know how you want me to proceed.
