

Kurt, After discussions with our outside counsel Paul Norman we would like to make some changes to the lien bill.

First we want to make clear that these changes to 342.22(1) override 422.306(4) Perhaps some language at the end of 342.22(1) such as "This paragraph applies to all motor vehicle security interests not withstanding 422.306(4)"

Also we would like change the liability to the owner from \$25 to \$250. \$250 is a more appropriate penalty.

Should these changes be made as simple amendments or a substitute amendment?

Also would you forward this e-mail to Chris in Harsdorf's office(I do not have his e-mail) so Senator Harsdorf can request the same changes to SB 197
