

**ASSEMBLY AMENDMENT 2,**  
**TO 2005 ASSEMBLY BILL 388**

July 12, 2005 - Offered by Representative WIECKERT.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 16: after that line insert:

3 "8. One member representing the nonprofit environmental or conservation  
4 profession."

5 **2.** Page 3, line 11: delete lines 11 to 13 and substitute:

6 "(b) "Revitalization" means any work or undertaking by a municipality to  
7 construct, reconstruct, renovate, redevelop, or rehabilitate buildings, structures, or  
8 other improvements at a site or facility to increase economic activity and tourism, or  
9 to create or improve public access to a lake or stream, in order to foster investment  
10 in the maintenance or restoration of the lake or stream as a natural resource and  
11 recreational amenity." ✓
