1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 9: after that line insert:

3 "SECTION 5m. 101.123 (2) (d) of the statutes is created to read:

4 101.123 (2) (d) A city, village, or town may enact an ordinance that allows
5 restaurants or taverns or both that are located in the city, village, or town to be
6 exempt from the applicable prohibitions under par. (a) 7. and 11. and (4) (a) 2m." (sub.)
