This bill prohibits any person from possessing, controlling, storing, or transporting live fish known as Asian carp. ✓

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 29.425 of the statutes is created to read:

4 **29.425 Possession of Asian carp.** No person may possess, control, store, or
5 transport a live Asian carp or its viable eggs.

6 **SECTION 2. Initial applicability.**

7 (1) This act first applies to Asian carp or their eggs that are acquired on the
8 effective date of this subsection. ✓
