TO 2005 ASSEMBLY BILL 482

in 8-2-05

1 At the locations indicated, amend the bill as follows:  
2 1. Page 7, line 17: delete lines 17 to 24 and substitute:  
3 "SECTION 6m. 71.03 (7) (d) of the statutes is amended to read:  
4 71.03 (7) (d) For taxable years beginning after December 31, 2002, and before  
5 January 1, 2005, for persons who served in support of Operation Iraqi Freedom or  
6 an operation that is a successor to Operation Iraqi Freedom in the United States, or  
7 for persons who qualify for a federal extension of time to file under 26 USC 7508, who  
8 served outside the United States because of their participation in Operation Iraqi  
9 Freedom or an operation that is a successor to Operation Iraqi Freedom in the Iraqi  
10 Freedom theater of operations.

SECTION 6n. 71.03 (7) (e) of the statutes is created to read:
