1 AN ACT ...; relating to: prohibiting certain rebate and refund offers.

*Analysis by the Legislative Reference Bureau*

This bill prohibits a retailer or manufacturer from offering a refund or rebate to a buyer in this state, unless the buyer receives the refund or rebate at the time and place of the sale.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

2 SECTION 1. 100.179 of the statutes is created to read:

3 100.179 Mail-in rebates prohibited. No retailer or manufacturer may offer  
4 to refund or rebate to a buyer in this state all or a portion of the sale price of goods  
5 unless the retailer or manufacturer gives the refund or rebate to the customer at the  
6 time and place of the sale.

7 SECTION 2. Effective date.

8 (1) This act takes effect on the first day of the sixth month beginning after the  
9 effective date of this subsection.
