Currently, 67.045(1)(f) reads: The governing body adopts a resolution to issue the debt by a vote of at least three-fourths of the members-elect, as defined in s. 59.001 (2m).

A few local officials in Brown County are using this statute to embarrass one of their colleagues at the detriment of our constituents. We aim to stop their childish abuse of the statutes by giving Counties more flexibility.

To do this we would very simply like to change "three-fourths" to "two-thirds."

1 AN ACT ...; **relating to:** changing the supermajority vote required of a county
2 board to issue certain debt.

Analysis by the Legislative Reference Bureau

Generally under current law, a county may not issue general obligation bonds or promissory notes unless one or more of several specified conditions apply. The conditions include the following:

1. A referendum is held that approves the debt issuance.
2. The debt is issued to fund or refund outstanding municipal obligations.
3. The county board adopts a resolution to issue the debt by a vote of at least three-fourths of the members-elect of the board.

This bill changes the three-fourths vote requirement to two-thirds.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 67.045 (1) (f) of the statutes is amended to read:

1 67.045 (1) (f) The governing body adopts a resolution to issue the debt by a vote
2 of at least ~~three-fourths~~ two-thirds of the members-elect, as defined in s. 59.001
