Dear Peter,

I would like two amendments drafted to Assembly Bill 631 (the Legislative Council bill creating a Tribal Charter School Authorizing Board).

The first amendment would allow the chartering authority to come into play only after a fully prepared charter school proposal has been presented to and turned down by the school board of the school district nearest to the proposed charter school.

The second amendment should say that no school currently in operation may convert to a "2 r" charter school. It is understood that the purpose of Assembly Bill 631 is to create new schools -- not to substitute state funding for schools already in operation and funded by other means.

I would appreciate it if you would draft both of these amendments **without** referring to or using the term Bureau of Indian Affairs (BIA).
