1. delete the sentence beginning on page 2, line 5 and ending on line 6.
2. define public land. My intent is to include all federal, state, county, local and tribal lands that are not used for a particular facility, like a state office. So, national forests and county forests would be included, for example. Also parks, conservation areas, etc. I would not include roads, bridges, etc. I don't know how to word this, but I assume the drafter can come up with suitable language.
