AN ACT to amend 21.19 (8); and to create 20.465 (1) (am) of the statutes;

relating to body armor for national guard members and making an appropriation

Analysis by the Legislative Reference Bureau

This bill requires the adjutant general or a designee to provide the latest version of the highest quality body armor to every resident who is a member of the national guard or of a reserve component of the U.S. armed forces called into the U.S. armed forces combat duty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows: Page 2, line 7, after that line insert:

SECTION 1.20.465 (1) (am) of the statutes is created to read:

5 20.465 (1) (am) National guard armor. A sum sufficient to provide body armor

to members of the national guard and reserves under s. 21.19 (8).

SECTION 2. 21.19 (8) of the statutes is amended to read:
