At the locations indicated, amend the substitute amendment as follows:

#. Page 1, line 2, delete "and".

#. Page 1, line 3, after "schools" insert

1 ~~AN ACT to amend 21.19 (8); and to create 20.465 (1) (am) of the statutes;~~
2 relating to body armor for national guard members, and making an
3 appropriation.

Analysis by the Legislative Reference Bureau

This bill requires the adjutant general or a designee to provide the latest version of the highest quality body armor to every resident who is a member of the national guard or of a reserve component of the U.S. armed forces called into the U.S. armed forces combat duty.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Page 2, line 7, after that line insert:

4 SECTION 1. 20.465 (1) (am) of the statutes is created to read:
5 20.465 (1) (am) *National guard armor*. A sum sufficient to provide body armor
6 to members of the national guard and reserves under s. 21.19 (8).
7 SECTION 2. 21.19 (8) of the statutes is amended to read:
