AN ACT to create 709.03 (form) D. 1m. of the statutes; relating to: disclosing whether residential rail property is located within a one-mile radius of an industrial or commercial facility that produces malodorous air emissions?

Analysis by the Legislative Reference Bureau

Under current law, with certain exceptions, owners who wish to sell residential real property must give prospective buyers a form, known as a real estate condition report, on which the owner discloses whether he or she is aware of various specified conditions, mostly defects, of the real property. The form also includes some additional information, such as how long the owner has lived on the property, and a notice that the prospective buyer and the owner may wish to obtain professional advice or inspections of the property.

This bill adds to the real estate condition report the requirement that the owner disclose whether he or she is aware that the real property is located within a one-mile radius of an industrial or commercial facility that emits into the air a substance or combination of substances that has an objectionable odor.
