November 9, 2005 – Offered by Representative LEHMAN.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 18: after that line insert:
- 3 **"SECTION 4m.** 118.40 (2r) (bm) of the statutes is amended to read:
- 4 118.40 (2r) (bm) The common council of the city of Milwaukee, the chancellor
- 5 of the University of Wisconsin–Milwaukee, and the Milwaukee area technical college
- 6 district board may only establish or enter into a contract for the establishment of a
- 7 charter school located in the school district operating under ch. 119. The chancellor
- 8 of the University of Wisconsin–Parkside may only establish or enter into a contract
- 9 for the establishment of a charter school located in a unified school district that is
- 10 located in the county in which the University of Wisconsin–Parkside is situated or
- 11 in an adjacent county. The chancellor of a university, other than those specified in
- 12 this paragraph, may only establish or contract for the establishment of a charter
