2 **1.** Page 5, line 7: delete lines 7 to 12 and substitute "inserts date", shall be
3 \$350,000 ~~\$550,000~~ for a person who is under the age of 18 at the time of the injury,
4 ~~and shall be \$450,000 for a person who is age 18 or over at the time of the injury, and~~
5 ~~those limits~~ shall be adjusted by the director of state courts to reflect changes in the
6 consumer price index for all urban consumers, U.S. city average, as determined by
7 the U.S. department of labor, at least annually thereafter, with the adjusted limit
8 limits to apply to awards subsequent to such adjustments."
