Amendment requested

I have already requested that "page 2, lines and 11-12 be deleted" and that may be the direction the committee takes. However, an alternative course of direction, would be as follows:

1. Delete that first point regarding information obtained while the person was trespassing;

2. Replace the deleted section with a provision that would allow use of the information gained by a person engaged in trespassing, but only if that person provided advance notice to the property owner before entering onto the privately owned property.

3. Notice here must be mailed by certified mail to the private property owner, dated to show that it was mailed out seven days in advance of a person entering onto the property [game wardens, drain commissioners, whomever).

4. A property owner that does not receive notice within 48 hours in advance of entry onto property, may still bring a challenge to exclude information subsequently brought forward.

5. Objtective: If this required advance notice is not afforded a property owner, then the information will be declared inadmissible, for it was not properly gained. Ultimately, DNR will request to keep copies of these notices mailed and certified mail, so that when the need arises to use information that was obtained, is not rejected upon presentation of notice to the administrative law judge.

Please draft an amendment to AB 884 that achieves this intent. Thank You.

A notice given under this subsection meets the requirements of this subsection only if it is dated in a manner that demonstrates that it was mailed to the property owner at least 7 days before the person entered the property.".
