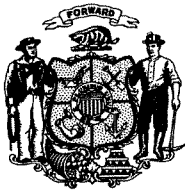

1 AN ACT ...; relating to: requiring a report on physician prescribing practices  
2 under Medical Assistance.

*Analysis by the Legislative Reference Bureau*

This bill requires that, by January 1, 2007, the Department of Health and Family Services submit to the legislature, including the joint committee on finance of the legislature, a report concerning prescriptions for drugs written by physicians in fiscal years 2004-05 and 2005-06 for recipients of the Medical Assistance Program or Badger Care. \*

For further information see the state fiscal estimate, which will be printed as an appendix to this bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*
