Hi Cathlene--

Please draft an amendment for Representative Suder to AB 969 to delete SECTION 4 which amends current law relating to the ability for DOJ to bring an action against a person if DOJ paid victim compensation to a victim of the person's criminal act. The language does not appear to be necessary because, as drafted, even if recompense is awarded to the victim, the bill does not require that amount to be subtracted from a judgment obtained by DOJ. Current law and the bill only require the amount of restitution paid into the general fund to be subtracted from the judgment amount. Also, if a victim is paid recompense under the bill and the defendant is later ordered to pay the victim restitution, an amount of restitution equal to the amount of recompense paid, if the restitution amount is higher than or equal to the recompense amount, or all of the restitution, if the amount is less than the recompense amount, is paid to the general fund and will be subtracted from the judgment amount.

The Assembly committee is scheduled to vote on the bill on Wednesday. Please put a copy of this into the drafting file and let me know if you have questions. Thanks!
